Following introductions, Dr. Rea advised Dr. Sukkarieh had been invited to discuss his application for a permanent license. Dr. Sukkarieh does not meet the licensure requirements for a permanent license and he has requested a waiver of the Board's Licensure regulation for a permanent medical license.

Following discussion and questions, a motion was made by Dr. Owens, seconded by Dr. McClendon, and carried to close the meeting to consider whether to enter into executive session on this matter.

A motion was made by Dr. Owens, seconded by Dr. McClendon and carried that the Executive Committee would enter into executive session for the purpose of considering whether or not Dr. Sukkarieh should be granted a waiver of the licensure requirement which could lead to an appeal of the Board's decision.

Upon a motion by Dr. McClendon seconded by Dr. Owens and carried the Executive Committee came out of executive session at which time Dr. Rea asked Dr. Owens to report on its

decision. Dr. McClendon reported that the Executive Committee will recommend to the Board to deny Dr. Sukkarieh's waiver request at this time.

Dr. Kistangari does not meet the licensure regulatory requirements of completing ACGME approved post graduate training for a permanent license and he has requested a waiver of the Board's Licensure regulation for a permanent medical license.

After discussion and questions from the Executive Committee, a motion was made by Dr. Owens, seconded by Dr. McClendon, and carried to recommend to the Board to deny the request of Kistangari to grant a waiver of the licensure requirements for a permanent medical license.
