## SURRENDER OF PODIATRIC LICENSE

WHEREAS, M SHAUN LUND, D.P.M., hereinafter referred to as "Licensee," is the current holder of Mississippi Podiatric Medical License No. 80222, issued on June 2, 2015, to practice podiatric medicine in the State of Mississippi;

WHEREAS, on or about June 16, 2022, an Indictment (the "Indictment") by a Grand Jury was filed in the United States District Court for the Northern District of Mississippi setting forth a number of counts and allegations against Licensee, to include conspiracy to defraud a health care benefit program, namely Medicare and TRICARE, related to podiatric foot bath medications;

WHEREAS, on or about February 2, 2023, Licensee met with the government and, at his plea hearing later that day, changed his plea to guilty related to Count I of the Indictment charging Licensee with conspiracy to commit healthcare fraud;

WHEREAS, the aforementioned guilty plea constitutes conviction of a felony or misdemeanor involving moral turpitude, in violation of Miss. Code Ann. § 73-27-13(1)(f) (1972), as amended, for which the Mississippi State Board of Medical Licensure may revoke said license or take any other action the Board may deem proper under the circumstances.

WHEREAS, Licensee has been sentenced to twenty-four (24) months imprisonment in the custody of the United States Bureau of Prisons and ordered to surrender for service of sentence before 2:00 p.m. on September 11, 2023. Further, upon release from

imprisonment, Licensee shall be on supervised release for a term of three (3) years. After successful completion of his incarceration and supervised release, Licensee may reapply for licensure with the Board. However, Licensee understands and acknowledges that if he elects to reapply, the application will be for issuance of a new license, and not a reinstatement of his current license. Licensee further understands that there is no guarantee that the Board will ultimately approve such a new application.

NOW, THEREFORE, in order to resolve this matter now pending before the Board, Licensee hereby voluntarily surrenders his license (No. 80222) to practice podiatric medicine in the State of Mississippi and understands said Surrender shall be effective immediately upon the start of Licensee's sentence. Licensee understands this is an unconditional surrender and is reportable to the National Practitioner Data Bank, and other entities such as the federation of State Medical Boards and is a public record of the State of Mississippi.

Recognizing his right to notice of charges specified against him, to have such charges adjudicated pursuant to Miss. Code Ann. § 73-25-27 (1972), to be represented therein by legal counsel of his choice, and to a final decision rendered upon written findings of fact and conclusions of law, M SHAUN LUND, D.P.M., nevertheless, hereby waives his right to notice and a formal adjudication of charges and hereby voluntarily executes this Surrender of Podiatric License.
