# ORDER OF TEMPORARY ACTION PENDING HEARING

**WHEREAS**, Priscilla Hogan Resser, P.A.-C, hereinafter referred to as "Licensee," currently holds Mississippi Physician Assistant License Number PA00473, said license is valid until June 30, 2024;

WHEREAS, the Mississippi State Board of Medical Licensure, hereinafter referred to as the "Board," upon determining that evidence in its possession indicates that a physician assistant's continuation in practice would constitute an imminent danger to public health and safety, has the authority, pursuant to Miss. Code Ann. § 73-25-63, to take any of the same actions on a temporary basis, without a hearing, which it could otherwise take under §§ 73-25-51 to 73-25-67 following a hearing, provided proceedings for a hearing before the Board are initiated simultaneously with such temporary action without a hearing, and a hearing to be held with at least fifteen (15) days' notice provided to the licensee:

WHEREAS, the Mississippi State Board of Medical Licensure has evidence in its possession indicating that Licensee failed to comply with an order to appear before the Examining Committee on April 26, 2024, for the purpose of determining Licensee's fitness to practice medicine with reasonable skill and safety to patients;

WHEREAS, the Mississippi State Board of Medical Licensure has further evidence in its possession indicating that Licensee's continued practice or unrestricted practice

would constitute an imminent danger to public health and safety pursuant to Miss. Code

Ann., § 73-25-63.

NOW, THEREFORE, IT IS HEREBY ORDERED, that pursuant to the

aforementioned authority, Mississippi Physician Assistant License Number PA00473,

issued to Licensee, is hereby suspended pending the outcome of a hearing scheduled

for July 18, 2024. Pending the scheduled hearing, Licensee is prohibited from treating,

counseling, or otherwise offering any medical advice or services to patients. Enclosed

herewith and served as part of this Order is a copy of the Determination with Affidavit and

accompanying Summons, finding the Board has in its possession evidence indicating that

Licensee's continuation in the practice or unrestricted practice of medicine would

constitute an imminent danger to public health and safety.

IT IS FURTHER ORDERED, that a copy of this Order shall be sent by certified

mail or personally served upon Priscilla Hogan Resser, P.A.-C, and shall be effective

immediately upon receipt thereof.

WHEREAS, the Board has in its possession evidence indicating that Priscilla Hogan

before the Examining Committee (the "Committee") of the Mississippi State Board of

Medical Licensure (the "Board") and failed to present for said appearance for

examination. Further, the Committee determined that Licensee represents an imminent

threat to public health and safety and should be restricted from the practice of medicine.

Said facts are set forth by Affidavit of Jonathan Dalton, Director of Investigations for the

Board, attached hereto and incorporated herein;

WHEREAS, said evidence indicates that Licensee's continuation in the practice or

unrestricted practice of medicine would constitute an imminent danger to public health

and safety.

NOW, THEREFORE, IT IS HEREBY ORDERED, that action should be taken without

a hearing, prohibiting Licensee from practicing medicine pursuant to authority granted in

Miss. Code Ann. § 73-25-63.

mail or personally served upon Priscilla Hogan Resser, P.A.-C, and should be effective

immediately upon receipt thereof.
